Public Comment

Donna McDonald with Lyon County Fair Board wished to address the Board because she was denied having her grant application accepted due to turning in the application a full week late. She said that the City's website stated that it is due no later than a week before the meeting, but Lori Phillips would not accept it. Secretary Lori Phillips stated that the very specific due dates were stated not only in the letter that was mailed to each applicant, but at the last Room Tax meeting where Ms. McDonald was in attendance. Ms. McDonald felt she should be allowed to present her application as it was unclear to her when was the actual due date.
